Membership Application Approval Process

- 1. Fill out the Membership Application completely and FAX to VRGuild at 817-428-2367.
2. Upon approval of the Application, a Membership Package will be mailed to the business address provided. This package will contain the VRGuild Membership Contract, the Governing Bylaws of the Association, and other pertinent information.
3. Upon the return receipt of signed documents by VRGuild, an amount of \$100.00 USD will be billed to the new member's credit card to cover Membership activation, and (2) hours of phone training. In addition, the Member will be billed for their annual dues. (\$250.00 for the first Primary Service Area, plus \$200.00 for each additional Primary Service Area.)
4. New Members will then contact the VRGuild to receive their user name & password and schedule initial training on the system.

- 5. To qualify for Membership, applicants are required to have a working Virtual Tour Camera Set, and access to High Speed Internet Service. (Minimum- Dual ISDN)

- 6. State sales tax issues governing Internet commerce are continually evolving. To eliminate VRGuild's need to charge sales tax, members are asked to provide a Federal Tax ID number, as well as a State Sales Tax ID number. *All members must provide the appropriate resale form for their State of operation.*

Terms and Conditions

1. All fees incurred through the utilization of the VRGuild system shall be charged to the Member's credit card on the 15th day of the month following the date the Administration Fee was incurred. A monthly itemized bill of all charges is available through member's online account.

2. Approved members are granted full access to the VRGuild system, and to the “Member Services” area. Membership in the VRGuild is subject to the terms and conditions, as outlined in the Membership Contract and Governing Bylaws.

3. VRGuild maintains the right to limit the number of Memberships granted in any geographical or Metropolitan area.

4. The VRGuild system is designed to facilitate the formation of a worldwide association of virtual tour producers. As such, any misuse of the tour posting system, or services available in the "Member Services" area will subject the Member to expulsion from the VRGuild's web site. Member shall be given warning prior any disciplinary action. Disagreements that arise between VRGuild members should be handled between concerned parties outside of the VRGuild. The posting of explicit materials deemed illegal by the laws of the State of Texas, USA to the VRGuild system is strictly prohibited.
